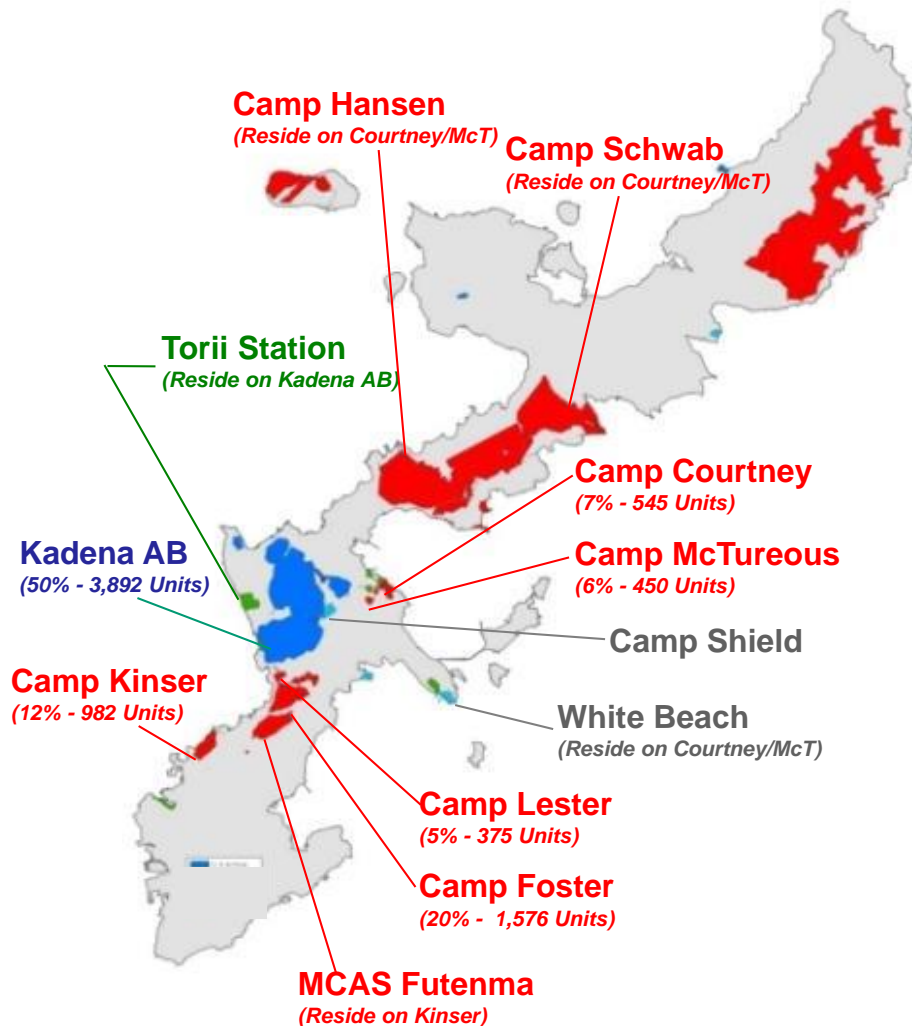

This chart represents the housing location primary and secondary area based on the members assigned duty location noted on the orders. Example: If you are stationed at Camp Foster, your primary area where your counselor will search for homes would be Camp Foster and the secondary area would be Camp Kinser.



Off-Base Authorization

- All inbound Military accompanied personnel will be required to reside on base if adequate units are available in the primary or secondary area. If no units are available to offer your counselor will provide the Request To Reside Off Base Memo
- Report any discrepancies to your Housing Counselor after viewing the offers.
 - If the discrepancies are not repairable in a timely manner, an alternate offer will be provided.
 - If your Housing Counselor has no units to offer in your primary or secondary area, she will send the Request To Reside Off Base Memo via email along with Off Base Briefing slides. The memo will need to be endorsed by any officer in your chain of command (that out ranks you) and returned to Kadena Housing Office.

Table A2.3. Bedroom Requirements Based on Family Size and Composition.

DEPENDENTS	BR AUTH
Spouse and/or one dependent	2
Two dependent children, except as follows:	2
When one is 10 years or older	3
When one child is 6 years or older and opposite gender	3
Three dependent children, except as follows:	3
When two are 10 years or older	4
When one is 10 years or older, one is 6 years or older and opposite gender of youngest	4
Four dependent children, except as follows:	3
When one is 10 years or older	4
When one is 6 years or older, and opposite gender of other three	4
When two are 6 years or older and opposite gender, and other two same gender	4
When two are 10 years or older and one is 6 years or older and opposite gender of youngest	4
Five dependent children, except as follows:	4
Two or more 10 years or older	5
One 10 years or older, one 6 years or older and opposite sex of the other three	5

If your children will age out of sharing a room during your tour, your Housing Counselor will offer a unit with an additional bedroom if available. No more than two children can share a room and they are not to share a room with adults.
