

# KADENA AB YOUTH SUPERVISION GUIDELINES

The ages specified are the minimum ages and are based on the child's ability to demonstrate age-appropriate behavior. Children/youth who do not consistently demonstrate age-appropriate behavior should not be given the same degree of self-management responsibilities. In all instances below where "yes" is indicated, youth in the specified age bracket may be left alone/perform activity. The parent is responsible for using reasonable judgment and for any incident of mishap (not considered preventable) which occurs.

<b>Footnote 1</b>	"I'm in Charge" training by Youth Center or Red Cross strongly encouraged.	<p><b>CURFEW</b></p> <p>Applies to all persons under the age of 18 or 18-20 who are currently enrolled in High School, a secondary school, or receiving other compulsory education.</p> <p>* Persons subject to curfew must be in quarters or with parent/designated caregiver during restriction times.</p> <p>* On Base - Weekends 2400-0530 (Friday evening through Sunday morning).</p> <p>* On Base - Weekdays 2200-0530 (Sunday night through Friday morning).</p> <p>* Off Base - Within Okinawa Prefecture 2200-0500 (Sunday through Saturday).</p>
<b>Footnote 2</b>	Caregiver is defined as a designated adult/babysitter that accepts responsibility for the child.	
<b>Footnote 3</b>	Periodic checks are when the adult meets with the minor in-person.	

- As an explanation:**
- Adult supervision is defined as someone 18 years or older who accepts responsibility for the child, e.g., parent, guardian, sibling, care provider, friend.
  - Caregiver is someone 12 years of age and older. (Red Cross Babysitting Course is highly encouraged)
  - Access is when the child has the ability to make immediate contact (in-person or electronically) with the caregiver.
  - Public areas include parks, playgrounds, sports fields, recreational areas, trails, etc.
  - Off-limits areas include uninhabited housing areas, tunnels, wooded areas, and areas that are fenced off.
