SUBJECT: Consolidated USFJ Off-Limits List

1. Component and Installation Commanders are responsible for determining off-limits areas applicable to all United States Military members covered under the United States-Japan Status of Forces Agreement (SOFA). Off-limits rules apply to any SOFA military member, regardless of their branch of service and the issuing component.
